Introduction

The Alaska Department of Health, Division of Public Health, Section of Epidemiology, is seeking letters of interest from qualified parties capable of and interested in providing database hosting and maintenance services for the Alaska version of the Centers for Disease Control and Prevention's (CDC) National Electronic Disease Surveillance System (NEDSS) Base System (NBS).

Background Information

The Division adopted the NBS System in Fall 2019 with a sole source contract for NBS hosting and maintenance services. The State is interested in assessing whether other entities may have the skills and background experience necessary to successfully meet its needs.

Scope of Work

The key function of this project is to host and maintain Alaska's NBS, encompassing the following activities, among others:

- Onboard, monitor, maintain existing and new electronic lab feeds;
- Onboard, monitor, maintain existing and new electronic case reporting feeds;
- Active engagement with trading partners, whether local, regional, or national;
- Interface with the Alaska Health Information Exchange (HIE);
- Provide support for user provisioning;
- Manage and maintain reporting outbound data to the CDC;
- Provide ad hoc data reports and database query support;
- Install updates and enhancements to pages and/or produce customized pages/reports.

Deliverables

The State of Alaska requires a system with minimal downtime that is managed effectively to house public health surveillance data.

- Ensure the State meets national reporting standards to CDC;
- Maintain electronic laboratory reporting (ELR) and electronic case reporting (eCR) feeds;
- Ensure data can be extracted in meaningful reports internally and for obtaining federal grant metrics, such as proportion of cases received through electronic means, time from report to investigation, etc.;
- Provide ad hoc data reports and database query support;

- Install updates and enhancements to existing and legacy pages;
- Develop and produce customized pages/reports.

Preferred Minimum Experience

The Division is looking for the following qualifications and experience in a contractor:

- 1. Detailed knowledge of the NBS system and ability to configure settings to the security specifications required by the Alaska Office of Information Technology;
- 2. Demonstrated history of successfully hosting NBS for a state or equivalent jurisdiction to include:
 - a. Demonstrated ability to host and integrate data from other disease surveillance systems, including syndromic surveillance systems and other infectious disease surveillance systems;
 - b. Knowledge of eCR functionality and methods of integrating eCR data into NBS;
 - c. Experience in programming for data extraction and customized report development;
 - d. Knowledge of ELR functionality, including integration of the Association of Public Health Laboratories Informatics Messaging Services feed and HIE feeds, as well as methods of creating and maintaining outbound interjurisdictional ELR feeds; and
 - e. Knowledge of NBS best practices from regular engagement in existing NBS subject matter expert (SME) and user meetings;
- 3. Experience in using Rhapsody for data transport;
- 4. Demonstrated experience working with external partners, including laboratories, hospitals, the NBS GDIT team, and various CDC surveillance teams;
- 5. Knowledge and experience with CDC message mapping guides, the NBS and other Data Modernization Initiatives (DMI), as well as the NorthStar Architecture.

<u>Budget</u>

The Department of Health, Division of Public Health has a budget of \$300,000 to \$400,000 per year to utilize over the next ten years in support of this contract.

Contract period: the length of this contract will be approximately one (1) year with nine (9) optional one-year renewals.

6. Provide narrative statements in response to the question/requested specifications listed above. (See *Questions*.)

7. A summary of any concerns regarding the project as described, and what potential obstacles should be anticipated
