The Department of Law has reviewed the attached regulations of the Department of Labor and Workforce Development and the Alaska Workers' Compensation Board against the statutory standards of the Administrative Procedure Act. Based upon our review, we find no legal problems. This letter constitutes the written statement of approval under AS 44.62.060(b) and (c) that authorizes your office to file the attached regulations. The regulations were adopted by the Department of Labor and Workforce Development and the Alaska Workers' Compensation Board after the close of the public comment period. Please note, the adoption order specified a requested effective date of January 1, 2024. Accordingly, these regulations are effective January 1, 2024 under AS 44.62.180(4).

The regulation changes concern updates to allowable fees and charges for medical treatments and related medical fee schedules adopted by reference.

The September 10, 2023 public notice and the October 24, 2023 certification order both state that this action is not expected to require an increased appropriation. Therefore, a fiscal note under AS 44.62.060 is not required.

We have made some technical corrections to conform the regulations in accordance with AS 44.62.060. The corrections are incorporated into the attached copy of the regulations.
