Changes to the RFP:

Change 1: The following section is updated:

SEC. 1.03 DEADLINE FOR RECEIPT OF PROPOSALS

In place of Amendment 1 verbiage reading, “Proposals must be received prior to 2:30 p.m. prevailing Alaska time on Friday, November 17, 2023. Late proposals or amendments will be disqualified and not opened or accepted for evaluation,” **substitute the following:**

“Proposals must be received by 2:30 p.m., prevailing Alaska time on Monday, December 4, 2023. Late proposals or amendments will be disqualified and not opened or accepted for evaluation.”

Change 2: The following section is updated:

SEC. 1.06 QUESTIONS PRIOR TO DEADLINE FOR RECEIPT OF PROPOSALS

In place of Amendment 1 verbiage reading, “All questions must be in writing and directed to the procurement officer. The interested party must confirm telephone conversations in writing.

All questions must be received no later than 12:00 p.m. (AKST) on Wednesday, November 15, 2023.

Two types of questions generally arise. One may be answered by directing the questioner to a specific section of the RFP. These questions may be answered over the telephone. Other questions may be more complex and may require a written amendment to the RFP. The procurement officer will make that decision.
