Why is employment for Alaskans with disabilities important?

- 1. When Alaskans with disabilities are employed, they have the opportunity to contribute positively to their communities, pay taxes, and experience meaningful engagement that reduces isolation and promotes health and well-being.
- 2. Employment is a pathway to independence and financial security for many Alaskans.
- 3. Employment is an essential part of recovery for many individuals with behavioral health conditions, offering positive impacts on life satisfaction, self-esteem, independence, and symptom reduction.
- 4. It is important that employment services are flexible to meet the needs of individuals.
- 5. In 2014, Alaska passed legislation to become an "Employment First" state. Employment First means that employment in the general workforce should be the first and preferred option for individuals with disabilities receiving assistance from publicly funded systems.
