Dear Lieutenant Governor Dahlstrom:

The Department of Law has reviewed the attached regulations of the Department of Revenue against the statutory standards of the Administrative Procedure Act. Based upon our review, we find no legal problems. This letter constitutes the written statement of approval under AS 44.62.060(b) and (c) that authorizes your office to file the attached regulations. The regulations were adopted by the Department of Revenue after the close of the public comment period.

The regulations repeal language that stated that the department would post an electronic list of the names of applicants for the permanent fund dividends. The repeal effectively requires anyone requesting the list to approach the department for a paper copy. The repeal is a fraud reduction measure.

The regulations also repeal disused language that allowed someone to use a method other than the department's "Pick, Click, Give" program, on the electronic permanent fund dividend application, to participate in the state's education raffle.

We note that the adoption order identifies a special effective date of January 1, 2024, for these regulations. Accordingly, we respectfully request that the regulations be filed on or before December 2, 2023.

The September 10, 2023, public notice and the December 1, 2023 adoption order both state that this action is not expected to require an increased appropriation. Therefore, a fiscal note under AS 44.62.060 is not required.

We have made some technical corrections to conform the regulations in accordance with AS 44.62.060. The corrections are incorporated into the attached copy of the regulations.
