Dear Lieutenant Governor Dahlstrom:

The Department of Law has reviewed the attached regulations of the Department of Commerce, Community and Economic Development against the statutory standards of the Administrative Procedure Act. Based upon our review, we find no legal problems. This letter constitutes the written statement of approval under AS 44.62.060(b) and (c) that authorizes your office to file the attached regulations. The regulations were adopted by the Department of Commerce, Community and Economic Development after the close of the public comment period.

The regulations make various update and cleanup changes to the general occupational licensing functions under 12 AAC 02. These include the repeal of outdated language and acronyms, repeal of non-existent administrative fees, update of fingerprint processing and application fees, new provisions to make fingerprint processing fees consistent across occupations, clarifications on renewal for applicants who receive a license within 90 days of the close of the renewal period, the repeal of an unnecessary requirement that a spouse applicant for a temporary military courtesy license must provide a copy of their military dependent identification card, and practical updates to the department's process to audit licensees for continuing competency compliance.

Both the Oct 12, 2023 public notice and November 24, 2023 adoption order state that this action is not expected to require an increased appropriation. Therefore, a fiscal note under AS 44.62.060 is not required.

No technical corrections were necessary to conform the regulations in accordance with AS 44.62.060.
