

Notice of Utility Tariff Filing

The REGULATORY COMMISSION OF ALASKA (Commission) gives notice that Matanuska Electric Association, Inc. (MEA) filed TA554-18, proposing to revise some of its non-recurring and streetlight installation charges. A selection of the current and proposed charges is shown below.

MEA proposes to remove the charge for meter read and proposes a new charge for after-hours disconnect/reconnect of \$1,080.00. In addition, MEA proposes to discontinue installation of new high-pressure sodium (HPS) streetlights while continuing to offer service to existing HPS streetlight customers at the current rates.

This notice does not contain all requested revisions and the Commission may approve a rate or classification which varies from that proposed.
