SOUTH THORNE BAY AREA FIVE YEAR SCHEDULE OF TIMBER SALES FISCAL YEARS 2025-2029

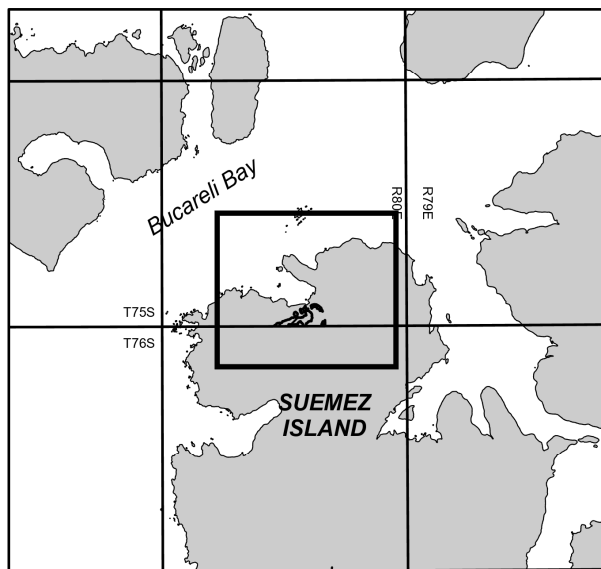
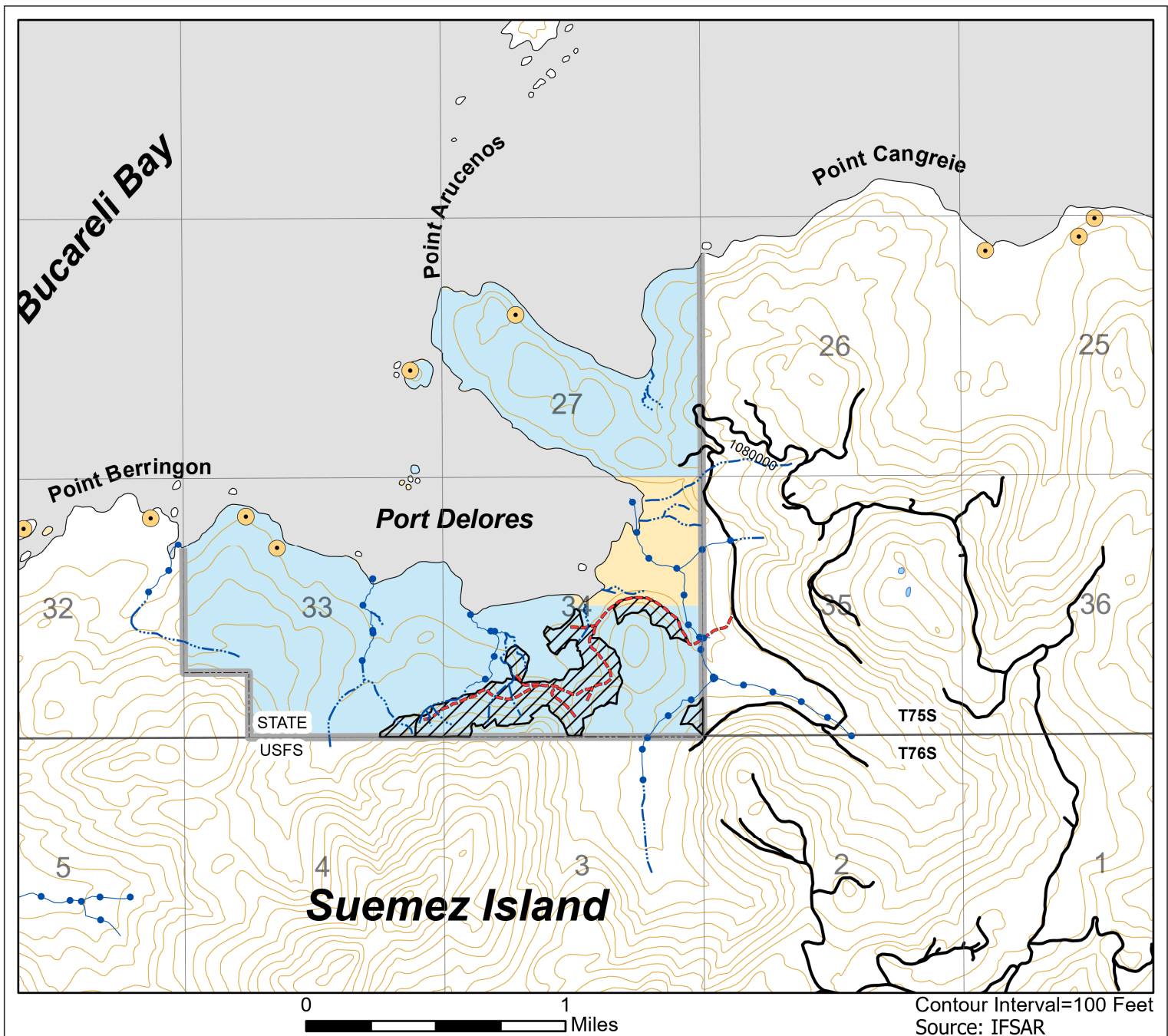
