## Dear Lieutenant Governor Dahlstrom:

The Department of Law has reviewed the attached regulations of the Board of Veterinary Examiners against the statutory standards of the Administrative Procedure Act. Based upon our review, we find no legal problems. This letter constitutes the written statement of approval under AS 44.62.060(b) and (c) that authorizes your office to file the attached regulations. The regulations were adopted by the Board of Veterinary Examiners after the close of the public comment period.

Reflecting recent statutory changes to AS 08.98 under ch. 14, SLA 2023 (SCS HB 56(L&C)), the regulations update education and examination requirements and remove now redundant requirements for compliance with the Prescription Drug Monitoring Program (PDMP) controlled substance prescription database under AS 17.30.200.

The December 12, 2023 public notice and the February 2, 2024 certification of adoption order both state that this action is not expected to require an increased appropriation. Therefore, a fiscal note under AS 44.62.060 is not required.

We have made some technical corrections to conform the regulations in accordance with AS 44.62.060. The corrections are incorporated into the attached copy of the regulations.
