## NOTICE OF PROPOSED REGULATION CHANGES ON THE MARICULTURE REVOLVING LOAN FUND ELIGIBILITY IN THE REGULATIONS OF THE DIVISION OF INVESTMENTS

## BRIEF DESCRIPTION

The Department of Commerce, Community, and Economic Development, Division of Investments proposes to adopt regulation changes in Title 3 of the Alaska Administrative Code.

3AAC 80.410 – 3AAC 80.480 is proposed to be amended through the addition of new subsections and language clarifying application requirements and review for the Mariculture Revolving Loan Fund Eligibility, along with revisor edits under AS 44.62.125.
