**LEASE TERM:** 55 years, beginning August 1, 2024, and ending July 31, 2079.

**CURRENT LEASE RENTAL RATE:** The annual rent is \$532,785.42 (\$0.18 per square foot x 2,959,919 square feet).

**PROPOSED AUTHORIZED USES:** Aircraft parking, aircraft fueling, cargo offload/load, Cargo Warehousing, ground handling, aircraft technical support, line maintenance, Flight crew operations base and regional office, GSE storage and repair.
