PUBLIC SCHOOL LEASE AMENDMENT No. 1

This amendment is made by mutual agreement of the parties of a Public School Lease dated August 30, 2004 and recorded in the Manley Hot Springs Recording District, Alaska as document number 2004-000095-0, which was entered into, by and between the State of Alaska, Department of Commerce, Community, and Economic Development, as trustee for any future city in Minto, Alaska as Lessor, whose address is 550 W.7th Ave, Suite 1650, Anchorage, Alaska 99501, and the Yukon-Koyukuk School District as Lessee, whose address is 4762 Old Airport Way, Fairbanks, Alaska 99709.

The parties agree to amend the Public School Lease as follows:

Paragraph 1 is amended to read:

1. The Land

The Lessor, in consideration of the mutual agreements and covenants contained in the lease agrees to lease to the Lessee the right to construct, operate, and maintain a public school complex on the surface estate of the following real property (hereafter called "the land"):

The surface estate of that certain real property located within Sections 22 and 27, Township 4 North, Range 9 West, Fairbanks Meridian, more particularly described as Block 15, containing 6.84 acres, and a portion of Block 16, containing 1.55 acres, of Plat 2017-1 recorded in the Manley Hot Springs Recording District, as depicted on Appendix A.

Aggregating to a total of 8.39 acres, more or less.

It is understood and agreed to between the parties hereto that, except as amended above, all terms and conditions of the Public School Lease remain in full force and effect.
