Dear Lieutenant Governor Dahlstrom:

The Department of Law has reviewed the attached regulations of the Department of Education and Early Development, Alaska State Council for the Arts against the statutory standards of the Administrative Procedure Act. Based upon our review, we find no legal problems. This letter constitutes the written statement of approval under AS 44.62.060(b) and (c) that authorizes your office to file the attached regulations. The regulations were adopted by the Department of Education and Early Development Alaska State Council for the Arts after the close of the public comment period.

The regulations concern the establishment of the registration fees for license plates celebrating the arts. The Council set the fee at \$3.

The August 13, 2023, public notice and the June 28, 2024, certification of adoption order both state that this action is not expected to require an increased appropriation. Therefore, a fiscal note under AS 44.62.060 is not required.

REGULATIONS OF ALASKA STATE COUNCIL ON THE ARTS

The attached 1 page of regulations, dealing with the Arts Vehicle Registration Plates, is certified to be a correct copy of the regulation changes that the Alaska State Council on the Arts adopted at its meetings, on September 15, 2023 and November 30, 2023 under the authority of AS 28.10.421 and after compliance with the Administrative Procedure Act (AS 44.62), specifically including notice under AS 44.62.190 and 44.62.200 and opportunity for public comment under AS 44.62.210.

This action is not expected to require an increased appropriation.

Although no public comments were received, the Alaska State Council on the Arts paid special attention to the cost to private persons of the regulatory action being taken.

The regulation changes described in this order take effect on the 30th day after they have been filed by the lieutenant governor as provided in AS 44.62.180.

Chapter 30. Alaska State Council on the Arts.

20 AAC 30 is amended by adding a new section to read:

20 AAC 30.896. Fee for vehicle registration plate celebrating the arts. (a) An applicant for a vehicle registration plate celebrating the arts shall pay the fees set out in AS 28.10.421.

(b) For the first issuance of a vehicle registration plate celebrating the arts, the applicant shall pay a one-time \$3 fee at the time provided in AS 28.10.108. (Eff. 8 / 2 / 2024,

Register 251)

Authority: AS 28.10.421 AS 44.27.052
