Delegation of Authority

Per AS 44.17.010 the following personnel are authorized to issue emergency orders in accordance with the manual, "Drafting Manual For Emergency Orders" as defined in AS 16.05.060, Emergency Orders.

This delegation of authority may be exercised in the opening and closing of sport fisheries, modifications to bag and possession limits and methods and means in sport fisheries, personal use and subsistence fisheries.

The following personnel are also authorized to issue permits under Title 5, Alaska Administrative Code, 5 AAC 01, 5 AAC 47 through 5 AAC 75, and 5 AAC 77.

This memorandum supersedes all other delegations of authority to issue emergency orders and permits and remains in effect until further notification. Per AS 44.62.175(a)(6), this document will be made available on the Alaska Online Public Notice System.
