Dear Lieutenant Governor Dahlstrom:

The Department of Law has reviewed the attached regulations of the Department of Fish and Game against the statutory standards of the Administrative Procedure Act. Based upon our review, we find no legal problems. This letter constitutes the written statement of approval under AS 44.62.060(b) and (c) that authorizes your office to file the attached regulations. The regulations were adopted by the Department of Fish and Game after the close of the public comment period.

The regulations update, from 2024 to 2025, the 2025 eLogbook Backup/Transcription Logbook for Saltwater Charter Operators and Vessel Registration, adopted by reference, and required for sport fishing guides if the charter operator is operating in saltwater; and the 2025 Vessel Registration, adopted by reference, and required for sport fishing guides if the charter operator is operating in fresh water.

The October 9, 2024 public notice and the November 12, 2024 adoption order both state that this action is not expected to require an increased appropriation. Therefore, a fiscal note under AS 44.62.060 is not required.

Because publication of the guides is calendar year-sensitive, we respectfully request that these regulations be filed on or before December 2, 2024.

No technical corrections were necessary to conform the regulations in accordance with AS 44.62.060.
