

NOTICE OF PROPOSED CHANGES TO LABELLING REQUIREMENTS FOR
MARIJUANA TEST RESULTS IN THE REGULATIONS OF THE MARIJUANA CONTROL
BOARD

BRIEF DESCRIPTION

The Marijuana Control Board proposes to change regulations dealing with labelling requirements for marijuana test results.

The Marijuana Control Board proposes to adopt regulation changes in Title 3, Chapter 306 of the Alaska Administrative Code, dealing with labelling requirements of test results for a marijuana cultivation facility transporting wholesale marijuana to another marijuana establishment, including the following:

- (1) 3 AAC 306.475(e) is amended to remove paragraph (4) that required a statement listing contaminants on the label affixed to the shipping container.
- (2) 3 AAC 306.475(f) is a conforming amendment.
- (3) 3 AAC 306.475(g) proposes to add a new subsection that allows a marijuana cultivation facility transporting wholesale marijuana to another marijuana establishment for retail or for use in manufacturing, to provide, upon request, a statement listing any contaminants for which the product was tested.
- (4) 3 AAC 306.990(b) is amended to add a new paragraph to define “filth”.

You may comment on the proposed regulation changes, including the potential costs to private persons of complying with the proposed changes, by submitting written comments to Alcohol and Marijuana Control Office at 550 W. 7th Avenue, Suite 1600, Anchorage, Alaska, 99501. Additionally, the Marijuana Control Board will accept comments by electronic mail at amco.regs@alaska.gov. Comments may also be submitted through the Alaska Online Public Notice System, by accessing this notice on the system and using the comment link. **The comments must be received not later than 4:30 p.m. on January 2, 2025.**

You may submit written questions relevant to the proposed action to Alcohol and Marijuana Control Office by email to amco.regs@alaska.gov or by mail to 550 W. 7th Avenue, Suite 1600, Anchorage, Alaska, 99501. The questions must be received at least 10 days before the end of the public comment period. The Alcohol and Marijuana Control Office will aggregate its response to substantially similar questions and make the questions and responses available on the Alaska Online Public Notice System and <https://www.commerce.alaska.gov/web/amco/>.

After the public comment period ends, the Marijuana Control Board will either adopt the proposed regulations or other provisions dealing with the same subject, without further notice, or decide to take no action. The language of the final regulation may be different from that of the proposed regulation. You should comment during the time allowed if your interests could be affected.
