

## Proposed Changes on Child Care Assistance in the Regulations of the Department of Health

Public Comment Received October 9, 2024 – November 18, 2024

On October 9, 2024, the Department of Health (DOH) proposed changes to regulations on Child Care Assistance published via the Alaska Online Public Notice system under *NOTICE OF PROPOSED CHANGES ON CHILD CARE ASSISTANCE IN THE REGULATIONS OF THE DEPARTMENT OF HEALTH.* The notice was also published in the Anchorage Daily News. An oral hearing was held on November 14, 2024, 1:00 p.m. to 3:00 p.m. to allow for oral presentation and public comments. The public comment period closed at 5:00pm on November 18, 2024.
