Dear Lieutenant Governor Dahlstrom:

The Department of Law has reviewed the attached regulations of the Department of Health against the statutory standards of the Administrative Procedure Act. Based upon our review, we find no legal problems. This letter constitutes the written statement of approval under AS 44.62.060(b) and (c) that authorizes your office to file the attached regulations. The regulations were adopted by the Department of Health after the close of the public comment period.

The regulations update the title of the quarterly publication used to adjust rates for inflation and adopt by reference the updated *Chart of Community Behavioral Health and Mental Health Physician Clinic Medicaid Covered Service Rates*.

Please note that the chart has both a version date, which is complete, and a blank for the effective date. We respectfully request that you fill in the effective date once the regulations are filed and the effective date is known.
