SMS Bill Tracking tool from BASIS

(Bill Action & Status Inquiry System)

This tool allows you to keep up with the proposed bills throughout the legislative process by sending you up-to-date text alerts as hearings are scheduled and posted in BASIS, and bill status changes.

SMS Bill Tracking! Text a bill number (ex: HB1) to 559-245-2529 to enroll in text alerts. You will receive an enrollment confirmation and instructions on how to stop receiving the alerts.
