





Overview and Goals of Rate Review

Purpose of the LTSS Rate Study:

- 1. Increase healthcare access to all Alaskans
- 2. Review existing rate methodologies and compare to other states
- 3. Understand differences in costs and rates between geographies within the State
- 4. Review rates for similar services offered across programs and divisions for alignment
- 5. Engage with community partners, such as Tribal Health Organizations (THOs)
- 6. Adjust rate methodologies to respond to people of all age groups and level of need
- 7. Complete a financial analysis that supports sustainability
- 8. Provide recommendations for implementation

- 2. Peer State Comparisons
- 3. Provider Survey
- 4. Rate Models
- 5. Fiscal Impact Analysis
- 6. Final Report with Rate and Implementation Recommendations

Wages


Types of employees

Consideration of participant's specific needs (team dynamics, staffing ratios)



Recognizes the costs of services with service-specific variations

Approach using statespecific data sources to develop the estimates for each cost component for each service

Assumptions can be derived from state, national or industry standard data
