

Chapter 32. Electrical Administrators.

12 AAC 32.325(b) is amended to read:

(b) A continuing education workshop sponsored by an individual or organization not identified in (c) of this section must be individually approved by the department. The department will approve a continuing education workshop if **the workshop's sponsor submits a continuing education approval application on a form provided by the department that includes**

[(1) A DESCRIPTION OF THE WORKSHOP AND THE NUMBER OF HOURS OF INSTRUCTION ARE SUBMITTED TO THE DEPARTMENT;]

(1) a description of the workshop's content and how the content [(2) THE DEPARTMENT DETERMINES THAT THE WORKSHOP] meets the requirements in (a) of this section;

(2) documentation of successful completion if the workshop has already occurred;

(3) a copy of the certification that will be provided to a successful participant if the workshop has not yet occurred;

(4) the number of contact hours requested to be awarded to a participant who successfully completes the workshop; and

(5) the sponsor's name, address, and telephone number [;

(3) THE WORKSHOP REQUIRES PARTICIPANTS TO REGISTER; AND

(4) SATISFACTORY COMPLETION OF THE WORKSHOP IS VERIFIABLE].

12 AAC 32.920. Change of employer or company affiliation. Repealed [A LICENSED ELECTRICAL ADMINISTRATOR SHALL NOTIFY THE DEPARTMENT IN WRITING WITHIN 15 DAYS AFTER A CHANGE IN ELECTRICAL ADMINISTRATION EMPLOYMENT OR COMPANY AFFILIATION BY SUBMITTING THE CHANGE OF EMPLOYER OR COMPANY AFFILIATION FEE ESTABLISHED IN 12 AAC 02.210 AND A NOTARIZED STATEMENT THAT INCLUDES THE

(1) NAME OF THE PREVIOUS COMPANY AND THE DATE EMPLOYMENT OR AFFILIATION ENDED;

(2) NAME OF THE NEW COMPANY AND THE DATE EMPLOYMENT OR AFFILIATION BEGAN;

(3) CONSTRUCTION CONTRACTOR LICENSE NUMBER FOR EACH COMPANY; AND
