Dear Lieutenant Governor Dahlstrom:

The Department of Law has reviewed the attached regulation of the Board of Nursing against the statutory standards of the Administrative Procedure Act. Based upon our review, we find no legal problems. This letter constitutes the written statement of approval under AS 44.62.060(b) and (c) that authorizes your office to file the attached regulation. The regulation was adopted by the Board of Nursing after the close of the public comment period.

The regulation amends 12 AAC 44.850 to replace experience restrictions for a proctor of a nurse aid competency examination with the requirement that the examination be administered and evaluated by a nationally-recognized credentialing service approved by the Board of Nursing.

The October 30, 2024 public notice and the March 25, 2025 order certifying changes state that this action is not expected to require an increased appropriation. Therefore, a fiscal note under AS 44.62.060 is not required.

No technical corrections were necessary to conform the regulations in accordance with AS 44.62.060.
