## QUESTIONS SUBMITTED BY VENDORS AND ANSWER FROM THE STATE

**Question 1:** Can you get clarification on how many simultaneous users would be using the Geophysics part of the software?

Items 2 and 6 are specific to Geophysics, I suspect that there would only be 4 or 5 simultaneous users not 13. Can you get confirmation on how many simultaneous Geophysics users are required for this ITB?

Item 7 refers to seismic attributes, I suspect there will be maximum 2 simultaneous users not 13? Is this a correct assumption for this ITB?

Answer 1: The vendor shall provide a bid for 13 simultaneous Geology licenses, 5 simultaneous Geophysics licenses, and 2 simultaneous Attributes users.

#### CHANGES TO THE ITB

#### **Change 1:** This portion of Sec. 1.02 Budget is being deleted:

The Department of Natural Resources, Division of Oil & Gas, estimates a budget of \$800,000.00 for the life of the contract, including all renewal options. Bids priced at more than \$800,000.00 will be considered non-responsive and will be rejected.

and replace with:

The Department of Natural Resources, Division of Oil & Gas, estimates a budget of \$800,000.00 for the life of the contract, including all renewal options. Bids priced at more than \$160,000.00 a year and bids priced at more than \$800,000.00 in total will be considered non-responsive and will be rejected.

#### **Change 2:** This portion Attachment 5 Bid Schedule is being deleted:

Bidders are to submit their bid using this Bid Schedule. Bidders that fail to complete this bid schedule shall be considered non-responsive and their bids rejected. Bid prices are to remain firm for the duration of the contract and are to include all costs associated with providing required services, including, but not limited to, direct expenses, payroll, supplies, equipment, overhead, and profit. The Total Contract Cost shown on Line 6 of this form is the cost that will be used for evaluation and award purposes under this ITB.
