PROPOSAL TO LEASE: The State of Alaska, Department of Transportation and Public Facilities, (DOT&PF) proposes to execute Terminal Lease Supplement No. 2 to ADA-32356 covering room NAA103, consisting of approximately 240 s.f., room NC101, consisting of approximately 1,134 s.f. in the North Terminal and room C1812, consisting of approximately 256 s.f., and room SA2743, consisting of approximately 202 s.f. in the South Terminal at the Ted Stevens Anchorage International Airport. **APPLICANT:** Unifi Aviation LLC. **TERM:** November 1, 2023, to October 31, 2028. Current Terminal rent rate is \$92.81/s.f./yr. **AUTHORIZED USES:** Storage of airline supplies for in-cabin use and office space.
