Dear Lieutenant Governor Dahlstrom:

The Department of Law has reviewed the attached regulations of the Department of Health against the statutory standards of the Administrative Procedure Act. Based upon our review, we find no legal problems. This letter constitutes the written statement of approval under AS 44.62.060(b) and (c) that authorizes your office to file the attached regulations. The regulations were adopted by the Department of Health after the close of the public comment period.

The regulations amend 7 AAC 135 to update standards related to Medicaid service authorizations and limitations for behavioral health state plan services. Changes include the removal of certain prior authorization requirements, replacing the 'in a fiscal year' requirement for the total hours a provider may provide short-term crisis intervention services to an 'in a single encounter' requirement, and updating the coverage and timing requirements for behavior identification assessments.

The April 2, 2025 public notice and the May 28, 2025 adoption order each state that this action is not expected to require an increased appropriation. Therefore, a fiscal note under AS 44.62.060 is not required.

Please note that the Department of Health has requested an effective date of July 1, 2025 to ensure that the state's Medicaid behavioral health state services plan remains effective upon the expiration of the Disaster Relief State Plan Amendment (SPA) on June 30, 2025.

No technical corrections were necessary to conform the regulations in accordance with AS 44.62.060.
