**NOTICE OF APPLICATION FOR LAND USE PERMIT:** The State of Alaska, Department of Transportation and Public Facilities (DOT&PF), Ted Stevens Anchorage International Airport (Airport) proposes to grant a land use permit under Lease ADA-32674, as follows: **LESSEE:** Alaska Airlines INC. **PREMISES:** Airport Hardstand K2, consisting of approximately 75,470 square feet. **LEASE TERM:** 6 months, beginning upon contract execution, and ending 6 months after contract execution. **CURRENT LEASE RENTAL RATE:** The annual rent is \$150,940 (\$2.00 per square foot x 75,470 square feet). **PROPOSED AUTHORIZED USES:** Use of hardstand K2 for aircraft repair operations and construction of a temporary maintenance structure.
