#### Dear Lieutenant Governor Dahlstrom:

The Department of Law has reviewed the attached regulations of the State Board of Education and Early Development against the statutory standards of the Administrative Procedure Act. Based upon our review, we find no legal problems. This letter constitutes the written statement of approval under AS 44.62.060(b) and (c) that authorizes your office to file the attached regulations. The regulations were adopted by the State Board of Education and Early Development after the close of the public comment period.

In accordance with ch. 36, SLA 2024 (SCS HB 230(EDC) am S(efd add S)), the regulations increase the number of consecutive days that a retired teacher may substitute teach, address incentive payments for teachers to hold national board certification, and address reimbursements to teachers pursuing initial national board certification or renewal of national board certification.

The February 5, 2025 public notice and the July 30, 2025 certification of adoption order both state that this action is not expected to require an increased appropriation. Therefore, a fiscal note under AS 44.62.060 is not required.

No technical corrections were necessary to conform the regulations in accordance with AS 44.62.060.

(e) A retired teacher certificate qualifies the holder to substitute teach for a teacher who district authorities know will be absent up to <u>165 consecutive</u> [120] days while the school is in session.

- **4 AAC 12.412. National board certification.** (a) If funding has been appropriated for teacher incentive payments and reimbursement of costs relating to national board certification under AS 14.20.225, the department shall notify each school district not later than August 31.
- (b) Upon notification under (a) of this section, a district shall provide to the department any requested information to establish incentive and reimbursable teacher costs under AS 14.20.225.
- (c) Subject to appropriation, a district or the department, as applicable, shall reimburse each teacher who is employed by the district or the department, and who is pursuing an initial national board certification or renewal of a national board certification, for the costs allowable under AS 14.20.225 that the teacher incurs on or after July 1, 2024.
- (d) In this section, "national board certification" has the meaning given in AS 14.20.225.
