This amendment is an official part of the ITB document and provides responses, clarifications, and modifications to the ITB requirements. All other terms and conditions remain unchanged.

ITB Documents, Clarifications and Questions:

1. Can you please clarify the item number requested as item 4? The title says Magpul MS1 but the actual item number, MAG518, is model MS4

DOC Response: The correct item for part number MAG518 is the Magpul MS4 model (or State-approved equivalent).

2. I was also just notified by the manufacturer that item 2, Vortex SPC-404 has been discontinued. Is there a state approved equivalent that you are interested in instead?

DOC Response: Vendors should quote the Holosun 403 HS403C as the State-approved equivalent.

3. The rifle specified is the 'Sionics Patrol 3' or 'State Approved equivalent' – How would we go about getting State Approved Equivalent status for our 16" Patrol Rifle?

DOC Response: To qualify a 16" Patrol Rifle as a State-approved equivalent, the rifle must:

- Be chambered for both 5.56 and .223
- Be gas operated
- Feature a Picatinny-style flat top for mounting optics
- Have a floating barrel
- Include an ambidextrous selector switch
- Have a barrel twist ratio of 1:7 or greater

4. There are 2 optics listed- I assume that you want pricing for both and will select one as opposed to buying 2 optics per system?

DOC Response: Vendors should provide pricing for both listed optics. The State will select one optic per system.

- Magpul PMAG 30 GEN 3 x 1
- Sprinco Enhanced Buffer Spring and Sprinco HD Extractor Spring

DOC Response: Yes. All items listed above, or State-approved equivalents, are to be included as part of the SIONICS Patrol Three rifle package in addition to the specifications listed in ITB 2026-2000-0049.
