

## **Notice of Utility Tariff Filing**

The REGULATORY COMMISSION OF ALASKA (Commission) gives notice that Chugach Electric Association, Inc. (Chugach) filed TA578-8, seeking approval of a wholesale power contract with the City of Seward d/b/a Seward Electric System (Seward) (2025 Agreement). The 2025 Agreement replaces the previous 2022 Agreement and maintains the same pricing structure, with interruptible, all-requirements service provided to Seward at Chugach's sale for resale tariff rates and wholesale surcharges. The term of the 2025 Agreement is three years with two successive three-year terms unless either Party provides written notice of termination to the other Party at least one year prior to the expiration. The 2025 Agreement also includes provisions transferring transmission cost recovery to the Railbelt Transmission Organization (RTO) once the RTO open access transmission tariff is approved. Chugach and Seward will be separately responsible for their allocated shares of the RTO's annual transmission revenue requirement, with limited exceptions for Seward's share of legacy transmission agreements and Chugach's Cooper Lake transmission line.

This notice does not contain all requested revisions, and the Commission may approve a rate or classification that varies from those proposed.
