

## **Notice of Application to Acquire a Controlling Interest in a Utility**

The REGULATORY COMMISSION OF ALASKA (Commission) hereby gives notice that on August 20, 2025, Ralph Eller (Applicant) filed an application for authorization to acquire a controlling interest in Tanana Power Company, Inc. (TPC). TPC holds Certificate of Public Convenience and Necessity No. 92 for the provision of electric service in Tanana, Alaska. The proposed transaction involves Ralph Eller acquiring ninety-nine percent holding of TPC. The proposed transaction will not result in a change of management, personnel, or utility equipment. Docket No. U-25-030 was opened to address this matter.

In conjunction with the application, Mr. Eller filed a petition for confidential treatment of his personal financial data filed as Exhibit B to the application. Interested persons may file a response to the petition for confidential treatment with the Commission by 5:00 p.m. September 15, 2025.

The Commission has not assessed the completeness of the application or ruled on the petition for confidential treatment. The Commission will rule on the petition for confidential treatment and determine if the application is complete after the close of the comment period.
