RENEWAL AND AMENDMENT NO. 1 OF LEASE (COMMUNITY HALL)

This renewal and amendment is made by mutual agreement of the parties of a Lease dated January 17, 1991, recorded as Document Number 1991-000308-0, Iliamna Recording District, Third Judicial District, State of Alaska, entered into, by and between the State of Alaska, Department of Community and Regional Affairs, which by act of law has been replaced by the Department of Commerce, Community, and Economic Development, as trustee for any future city in Pedro Bay (Lessor) whose address is 550 W 7th Ave, Ste 1650, Anchorage, Alaska 99501-3510, and the Pedro Bay Village Council (Lessee), whose address is P.O. Box 47020, Pedro Bay, Alaska 99647.


The parties agree to renew and amend the Lease as follows:

Sections 1, 3, and 21 are amended to read:

 The Land. The Lessor agrees to lease to the Lessee the exclusive right to construct, operate, and maintain a community hall on the following real property located in the vicinity of Pedro Bay (referred to as "the land"):

That surface estate of Lot 1A of Big Hill Subdivision recorded as Plat 2010-3 in the Iliamna Recording District, Alaska, located within Section 32, Township 4 South, Range 28 West, Seward Meridian, Alaska, containing 1.801 acres more or less.

- 3. <u>Term.</u> The term of the renewal of the lease is <u>30</u> years commencing on <u>January 17</u>, <u>2021</u>, and ending at midnight <u>January 16</u>, <u>2051</u>, unless sooner terminated as provided in this lease.
- 20. <u>Notices</u>. All notices and other writings required or permitted by this lease must be sent by registered or certified mail, postage prepaid, to the parties at the following addresses. A party must notify the other in writing of any changes in address:


The parties further agree that:

RENEWAL AND AMENDMENT NO. 1 LEASE (COMMUNITY HALL)

WHEREAS, the State of Alaska, Department of Commerce, Community, and Economic Development (DCCED), in trust for any future city that may be established in Pedro Bay, Alaska, has title to the surface estate of municipal trust lands located in Pedro Bay:

WHEREAS, the Lease for a community hall, dated January 17, 1991, and recorded in the Iliamna Recording District, State of Alaska, document number 1991-000308-0, by and between DCCED and Pedro Bay Village Council, expired on January 17, 2021:

WHEREAS, the Pedro Bay Village Council has requested renewal of the lease for an additional 30 years retroactive to and continuing from the original expiration date;

WHEREAS, AS 44.33.755 and 3 AAC 190.010 et seq. provide that the Commissioner of DCCED is designated to administer and dispose of such lands conveyed to the State in trust, and that the Commissioner may transfer an interest in such land only after obtaining the approval of an appropriate village entity;

WHEREAS, the Commissioner of DCCED proposes to renew and amend the Lease for a community hall by renewing for an additional 30-year term from the original expiration date, updated the legal description to conform to a new survey, and to amend and update notice contact information; and

WHEREAS, the Pedro Bay Village Council is the recognized appropriate village entity regarding the approval of such municipal trust land disposals in accordance with 3 AAC 190.430 and 3 AAC 190.460.

NOW THEREFORE BE IT RESOLVED, that the Pedro Bay Village Council approves the renewal and amendment of the Lease, and recommends the Commissioner of the DCCED issue said renewal and amendment to the Pedro Bay Village Council.
