Additionally, the project includes installation of a branching units connecting to new CLS' in Emmonak and Hooper Bay. From Naknek, a terrestrial cable will extend from the new CLS to an existing communication shelter in Igiugig, where it will connect into an existing GCI system of leased fiber pairs. While the terrestrial segments traverse several land ownerships (e.g., BLM, ADNR, etc.), the marine segments are managed by ADNR (State submerged and tidal lands).

Quintillion's Nome to Homer Express (NTHE) project proposes to install 894.07 miles of fiber optic cable from Nome to Igiugig, then interconnecting Quintillion's cable to leased fiber pairs on an existing GCI network from Igiugig to Homer. The NTHE project would include installation of a new submarine fiber optic cable from the existing Quintillion Cable Landing Station (CLS) in Nome to a new CLS in Naknek. Additionally, the project includes installation of a branching unit and cable branch connecting to a new CLS in Emmonak and Hooper Bay. From Naknek, a terrestrial cable will extend from the new CLS to an existing communication shelter in Igiugig, where it will connect to leased fiber pairs.

In the course of your proposed activity will you generate, use, store, transport, dispose of, or otherwise come in contact with toxic and/or hazardous materials, and/or hydrocarbons?

The only source of hazardous materials would be petroleum-based fuel, lubricant, and hydraulic oils used in the operation of terrestrial construction equipment as well as the cable ship and support vessels during cable-laying activities. Terrestrial construction would require a range of equipment including an excavator, backhoe, small utility vessel for water crossings, utility truck, rock saw, and chain trencher. All vessels and equipment would be equipped with appropriate spill response kits to immediately address any inadvertent releases of oil or fuel while the vessel is operating. All instruments and equipment would be checked prior to deployment to ensure that there are no contaminant leaks.
