

## AMENDED PERMIT AND CERTIFICATE OF APPROPRIATION LAS 29606

The State of Alaska, acting by and through the Department of Natural Resources, Division of Mining, Land and Water, 550 W. 7th Ave, Suite 1020, Anchorage, AK 99501-3562, hereinafter referred to as the grantor, under AS 46.15, the Alaska Water Use Act, and the regulations adopted under it, grants to:

Hilcorp Alaska, LLC 3800 Centerpoint Drive, Suite 1400 Anchorage, Alaska 99503

The right to the following use of water:

SOURCE:

2 Drilled Wells

QUANTITY: 164,383 Gallons / Day, with an annual limit 20,379,229 gallons

PERIOD:

January 1<sup>st</sup> Through December 31<sup>st</sup>

USE:

Oil Exploration, Production, and Facilities Management at Oliktok Point

With a PRIORITY DATE of April 24, 2014.

The location of this water source:

Two drilled wells, 81 and 84 feet deep, located within the below-described area of appurtenance.

## PERMIT AND CERTIFICATE OF APPROPRIATION LAS 29606

The location to which this water right is appurtenant:

Oliktok Point Oil Pad, located within Tract B of ATS 1289, according to the official plat thereof, filed under Plat No. 84-12, Barrow Recording District, Second Judicial District, State of Alaska.

The holder of this Permit and Certificate of Appropriation shall:

- 1. Follow acceptable engineering standards in exercising the water right granted by this permit and certificate.
- Except for claims or losses arising from negligence of the State, defend and indemnify the State against and hold it harmless from any and all claims, demands, legal actions, loss, liability, and expense for injury to or death of persons and damages to or loss of property arising out of or connected with the exercise of the water right granted by this permit and certificate.
- 3. Comply with all applicable laws, regulations, and conditions.
- 4. Notify the grantor of any change of address, transfer of any real property identified in this permit and certificate, or proposed change in the water appropriation.
- 5. Notify the Division of any major well maintenance work performed and submit a report to this office within 45 days of completion that includes testing data, maintenance results, date when the well was shut down and restarted, static water level, name of contractor who performed the work and the dates of work.
- 6. Permanent decommissioning of any well, must be in compliance with requirements of 18 AAC 80.015(e). Abandonment report shall be submitted to this office and DEC within 45 days.
- 7. Pursuant to AS 46.15.155(f), the Department may impose conditions or limitations on an authorization to protect the water rights of other persons or to protect fish and wildlife habitat, human health, or other public interests.
- Operations shall not cause or contribute to the spread of preexisting or authorization holder caused contaminant plumes. All spills and contamination encountered or known must be reported to the Alaska Department of Environmental Conservation (ADEC) and the Alaska Department of Natural Resources (DNR). Authorization holder shall cooperate with lawful prohibitions, restrictions, instructions, stop work orders or work plan requirements issued by ADEC for authorization holder's projects.
- 9. Comply with 18 AAC 80 and maintain direct contact with the ADEC-Drinking water point-of-contact for the region, Chris Pletnikoff, at chris.pletnikoff@alaska.gov, where applicable.

- 10. Monitor water use monthly and submit monthly water use reports annually to <a href="mailto:dnr.water.reports@alaska.gov">dnr.water.reports@alaska.gov</a> until notified otherwise.
- 11. Per 11 AAC 05.260(e), an annual administrative service fee shall be assessed on this authorization.

The water right is granted subject to the pertinent statutory provisions in AS 46.15 and Administrative Regulations in 11 AAC 93.

This Amended Certificate of Appropriation is issued to correct the purpose of use; and supersedes Certificate of Appropriation LAS 29606 issued on February 28, 2025, and recorded in the Barrow Recording District as Document No. 2025-000086-0 on March 3, 2025.

This Permit and Certificate of Appropriation is issued by authority of AS 46.15.080, AS 46.15.120, 11 AAC 93.120, and 11 AAC 93.130 on March, 4, 2025.
