ITB Documents, Clarifications and Questions:

1. **Vendor Question:** I opened the spreadsheet, but I do not see where to enter the dilutions for each product.

DOC Response: The bid schedule for this solicitation does not factor dilution rates; the Department of Corrections is seeking prices for the unit of measure listed for each product.

2. **Vendor Question:** I have a question concerning the Contract that was awarded to Ace Chemical for the DOC's Laundry, Kitchen and Housekeeping chemicals We understand Ace chemical is no longer selling the Accurate Chemicals they were awarded on the bid, Did Ace Chemical notify you they were Going to substitute the chemicals for the Doc locations?

DOC Response: No, Ace Chemical has not had a contract with the Alaska Department of Corrections for these products. Ace Chemical has not notified the State of any substitutions, and no substitution requests have been submitted or approved.

3. **Vendor Question:** Can you also confirm for me that the bid can be submitted via email? The verbiage under SEC. 1.06 is not clear. Unsure if submitting via email, if a hard copy is also required.

DOC Response: No, vendors may submit either a hard copy or an email bid. Because the solicitation provides two valid submission paths, either method satisfies the ITB requirements.

Changes: The original ITB stated the contract term as January 1, 2025, through December 31, 2026, with three optional one-year renewals through December 31, 2029.

This section is amended to read as follows:

SEC. 2.01 CONTRACT TERM (Revised)

The length of the contract will be from January 1, 2026, through December 31, 2027, with the option to renew for three (3) additional one-year terms, up to December 31, 2030, under the same terms and conditions as the original contract. Renewals will be exercised at the sole discretion of the State. All other terms and conditions of the ITB remain unchanged.

In order for your bid to be considered responsive, this amendment, in addition to your original bid, must be received by the issuing office of the Department of Corrections prior to the bid opening.
