In the introductory language of 9 AAC 16.040(c), please change "AS 45.66.090(1)" to "AS 45.66.090(b)(1)."

--In 9 AAC 16.040(e), please change "AS 45.66.090(3)" to "AS 45.66.090(b)(3)."

--In 9 AAC 16.040(f), please change "AS 45.66.090(5)" to "AS 45.66.090(b)(5)."

--In the introductory language of 9 AAC 16.040(g), please change "AS 45.66.090(7)" to "AS 45.66.090(b)(7)."

In addition, after 9 AAC 16.040, please insert an editor's note to read as follows:

Editor's note: As of Register 256 (January 2026), the regulations attorney, acting under AS 44.62.125(b)(6), made technical corrections to 9 AAC 16.040(c), (e), (f), and (g).

In the authority citation that follows 11 AAC 67.015, please delete the citation to AS 38.05.077, which the legislature repealed in 1983.

In addition, please add an editor's note after 11 AAC 67.015 to read:

Editor's note: As of Register 256 (January 2026), the regulations attorney, acting under AS 44.62.125(b)(6), corrected the authority citation that follows 11 AAC 67.015 to remove an obsolete citation to a repealed statute.
