The enclosed addendum amends the documents for the above-mentioned Project:

1. QUESTION: Method to send questions to AIDEA about the solicitation:

ANSWER: Please register as Plan Holder on the link provided: <https://www.aideaaeprocurement.org/Home/Registrar/4370>; and submit questions to email: procurement@aidea.org.

2. QUESTION: Deadline (date and time) to send questions to AIDEA about the solicitation?

ANSWER: January 14, 2026, Time:1:00PM AK Time

3. QUESTION: The RFP notes that proposals are to be hand delivered but also references alternate submittal methods. Can you confirm that email submittal of the proposal and required forms is acceptable?

ANSWER: Yes, Offerors may submit proposals via email as stated on page 2, Part A REQUEST FOR PROPOSALS PACKAGE:

"If submitting a proposal via email, the technical proposal and cost proposal must be saved as separate PDF documents and emailed to procurement@aidea.org as separate, clearly labeled attachments, such as the email must contain the RFP number in the subject line.

- "Vendor A – Technical Proposal.pdf" (Must include Part D – Proposal Form); and
- "Vendor A – Cost Proposal.pdf" (Vendor A is the name of the offeror).

The maximum size of a single email (including all text and attachments) that can be received is 20mb (megabytes). If the email containing the proposal exceeds this size, the proposal must be sent in multiple emails that are each less than 20 megabytes, and each email must comply with the requirements described above.

Please note that email transmission is not instantaneous. Similar to sending a hard copy proposal, if you are emailing your proposal, we recommend sending it ahead of time to ensure the email delivery meets the deadline for receipt of proposals. An Offeror's failure to submit its proposal prior to the deadline will cause the proposal to be disqualified. Late proposals or amendments will not be opened or accepted for evaluation.

It is the Offeror's responsibility to contact the AIDEA Chief Procurement Officer on phone number: 907-771-3909 or email: procurement@aidea.org, to confirm that the proposal has been received. Alaska Industrial Development and Export Authority is not responsible for unreadable, corrupt, or missing attachments."
