4. A.T.S. 1486 IS DEDICATED FOR PUBLIC USE AND PUBLIC ACCESS.


HORIZONTAL CONTROL DATA

THE BASIS OF BEARING FOR THIS PROJECT WAS THE GEODETIC BEARING OF N 17° 14' 42" E BETWEEN DOT/PF MONUMENTS "SWAN 1" AND "SWAN 2".

GEODETIC COORDINATES FOR "SWAN 1" AND "SWAN 2" WERE ESTABLISHED WITH GPS OBSERVATIONS ON 2/14/95 USING USC&GS MONUMENT "EDDIE" 1959, AN ORDER B STATION, AS BASIS OF COORDINATES. THE RESULTING NAD 83 COORDINATES WERE TRANSFORMED TO NAD 27 USING THE U.S. ARMY CORPS OF ENGINEERS COMPUTER PROGRAM "CORPSCON".

VERTICAL CONTROL DATA






