### **NOTICE TO THE PUBLIC AND REQUEST FOR INFORMATION LAS 35799 RODNEY J SCHUH**

Subject to AS 38.05.850, the Southcentral Regional Land Office has received an application for the following:

**APPLICANT:** RODNEY J SCHUH

**PROJECT NAME:** LAS 35799

**GEOGRAPHIC LOCATION:** Located 25 miles west of Mount Veniaminof on the north bank of the Sandy River about 5 miles downstream of Sandy Lake.

**LEGAL DESCRIPTION:** SW 1/4 of the NE 1/4 of Township 46 South, Range 69 West, Section 9, Seward Meridian

**REQUESTED ACTIVITY:** Applicant Rod Schuh is requesting a 5-year land-use permit for a seasonal hunting camp on state lands near Sandy Lake for the months of May then September through October. The camp would consist of one 24'x36' wood platform to facilitate one 12'x16' and two 10'x12' weather port structures. The wood platform will remain but all other materials will be cached on site when not in use. The permit would also allow for the use of two additional short-term portable camps in support of the base camp.

**PROPOSED DATES OF USE:**

Start: May 1, 2026

End: April 30, 2031

**DEADLINE FOR COMMENTS:** February 3, 2026

The public is invited to comment on this activity. The purpose of this notice is to gather input before a decision is made on this activity.
