Ester Dome Telecommunications Site Development Plan ADL410299

Legal Description. The location is in section 26 Township 1N range 3W Fairbanks Meridian

Terrain/ground cover. Ground coverage is level and cleared around the shelter, with small to medium spruce, cottonwood, and willow in the surrounding area. N 64-52-33 W 148-04-05 Elevation 720.5 meters

Access. Take Parks highway to Sheep Creek Rd Mile 355.8. Remain in Sheep Creek Rd. Go about 2 to 3 miles, cross RR tracks and take a left onto Ester Dome Rd. Take a left at the top of the hill and follow the road to the site.

Buildings and other structures. The site has 3 SOA communication shelters of various sizes from approximately 10X12 to 10X24 and one stand alone tower approximately 120 ft. There is also a Federal Communications shelter and 120' tower within the same fence perimeter.

Power source. Electrical power is from Golden Valley Electric with a 12kw generator as back up.

Waste types, waste sources, and disposal methods. The waste is material used at the sites which are no longer required. Disposal method is to haul waste off of sites when no longer needed at the location.

Hazardous substances. This site has a 12KW generator as a secondary power source with up to 45 gallons of diesel fuel stored on site. This site also has 48VDC batteries up to 3000 AH in size, currently 1200 AH sealed type, and generator starting battery.

Water supply. No water supply is required for operation of these sites.

Parking areas and storage areas. Parking will be on site when accessible. No storage areas are required.

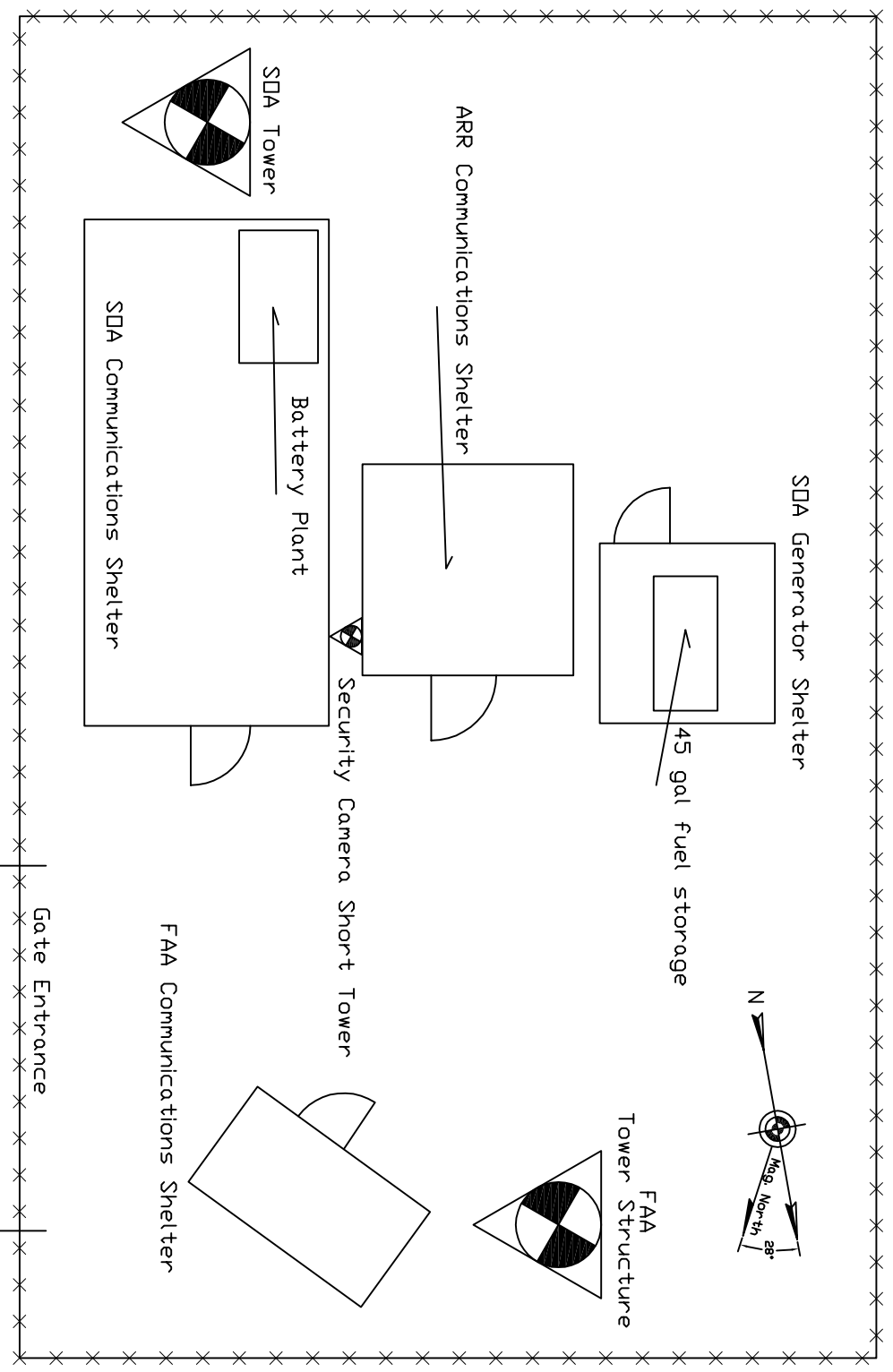
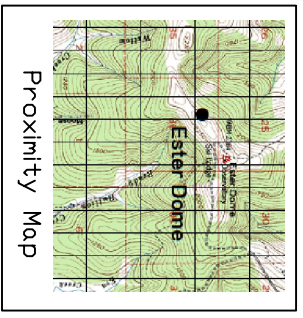
Number of people using the site. No one is physically present at the site.

Maintenance and operations. The facility is for providing public safety radio services to local, state, and federal government agencies. All of the equipment is automatic. This site will have remote alarm monitoring, including door open, fire and generator operation. The microwave radio at the site will carry voice and data circuits for many state agencies. Several remotely controlled radios at the site will support State agencies including Troopers, Forestry (fire fighting) and DOT (highways).

The site is serviced two to four times a year by a staff of one to three employees.

Closure/reclamation plan. When services provided by the facilities at this location are no longer required, equipment and structures will be removed from the location.
