

# NOTICE OF ALASKA DEPARTMENT OF TRANSPORTATION & PUBLIC FACILITIES, TED STEVENS ANCHORAGE INTERNATIONAL AIRPORT RENTAL CAR CENTER CUSTOMER FACILITY CHARGE AND FACILITY MAINTENANCE CHARGE RATE ADJUSTMENT

Notice is given that the Commissioner of the Department of Transportation and Public Facilities (DOT&PF), Ted Stevens Anchorage International Airport (ANC), under authority of AS 2.15.090(h), hereby gives notice to adjust the Customer Facility Charge (CFC) and Facility Maintenance Charge (FMC) that on-airport rental car concessionaires at ANC are required to collect from their rental car customers. The on-airport rental car concessionaires at ANC will continue to be required to remit the collected CFCs and FMCs to the appointed trustee to pay debt service on bonds sold to finance construction of the ANC consolidated rental car facility and pay for annual operations and maintenance costs, respectively.

**CUSTOMER FACILITY CHARGE (CFC):** The Commissioner of the DOT&PF proposes no changes to the CFC rate required to be collected from rental car customers at ANC and to remain at \$7.00 per vehicle rental day. **FACILITY MAINTENANCE CHARGE (FMC):** The Commissioner of the DOT&PF proposes to increase the FMC rate required to be collected from rental car customers at ANC from \$2.25 to \$3.15 per vehicle rental day.

**TOTAL COMBINED AMOUNT OF CFC AND FMC:** The combined proposed CFC and FMC rate will increase from \$9.25 to \$10.15 per vehicle rental day. The proposed adjustment is based on the Anchorage RAC, LLC's consultant's Feasibility Report dated December 22, 2025.

**EFFECTIVE DATE and TERM:** The proposed effective date of the FMC rate adjustment is March 2, 2026. Collection of the CFC and FMC will continue and may be further adjusted in the future until the related bond indebtedness is paid in full. All other previously established and in effect rates and charges remain unchanged unless otherwise noticed.

The land/building lease ADA-31367, the On-Airport Rental Car Concession Agreements, bond documents, consultant's report, and other associated documents are on file and available for inspection during regular business hours, Monday through Friday, at the Leasing Office of Ted Stevens Anchorage International Airport, located on the 3rd floor of the South Terminal.
