LEASE TERM: 50 years, beginning October 1, 2026, and ending September 30, 2076.
LEASE RENTAL RATE: The annual rent is \$14,888.70 (\$0.18 per square foot x 82,715 square feet).
AUTHORIZED USES: Construction, operation and maintenance of an air cargo warehouse/terminal building; Subleasing of real estate to tenants.
