NOTICE OF APPLICATION FOR SUPPLEMENT: The State of Alaska, Department of Transportation and Public Facilities (DOT&PF), Ted Stevens Anchorage International Airport (Airport) proposes to supplement a lease under Lease ADA-30816, as follows:

LESSEE: United Parcel Service, INC.

PREMISES: Block 27, Lot 1E, consisting of approximately 1,246,000 square feet.

LEASE TERM: 35 years, beginning October 1, 1997, and ending September 30, 2032.

PROPOSED LEASE RENTAL RATE: The annual rent is \$224,280 (\$0.18 per square foot x 1,246,000 square feet).

AUTHORIZED USES: Construction and operation of an air cargo facility, air cargo transfer, short term air freight build-up and break down, and aircraft parking and maintenance associated with these uses; sale and dispense aviation fuel and lubricants on the premises, ground handling and support maintenance and associated equipment storage, aircraft de-icing, and office support.
