IMPORTANT NOTE TO OFFERORS: Only the following items/sections referenced in this amendment are to be changed. All other terms and conditions of the original Request for Proposals remain the same. This amendment is being issued to provide the following updated information:

1. Addition of Attachment L10 - Pharmacy Benefit Management Non-Disclosure Agreement (NDA). Offerors who will be providing a quote on the Pharmacy Benefit Management RFP will have the opportunity to receive additional pharmacy claims information, if desired. Those Offerors are requested to complete Attachment L10 and send it directly back to Alaina Sandhu, with Buck Consultants, at Alaina.Sandhu@buckconsultants.com. Upon receipt of the NDA, Alaina will provide an electronic invitation to the vendor's preferred email address to sign up for the Buck Consultants Secure File Transfer System (SFTS); vendors will be requested to confirm successful enrollment with SFTS to Alaina via email, and will receive data within one (1) business day of such notification through the secure site.
