**The following questions have been asked and answered**

- Q.** I have a question about the Vendor Tax ID. Is that an Alaska tax ID number?
- A.** The vendor tax ID, also known as Employer Identification Number (EIN) is a number issued to you or your firm by the IRS.
- Q.** The Alaska Business License.... Do you want this as a new company that is set up just for this job?
- A.** At the time the proposals are opened, all offerors must hold a valid Alaska business license and any necessary applicable professional licenses required by Alaska Statute. Proposals must be submitted under the name as appearing on the person's current Alaska business license in order to be considered responsive.

- Q.** Is there any additional information you may supply regarding what a Conflict of interest (sec. 1.17) would be with the State of Alaska?
- A.** A potential conflict of interest could be a current or prior relationship with a current employee or public official with the Department of Commerce, Community and Economic Development. Offerors must disclose actual and potential conflicts of interest for determination at the time proposals are opened.
