**The following questions have been asked and answered:**

- Q.** Provide the most recent financial statements for the business and annual profit/loss balances for the past three years. Will IRS tax returns suffice for P&L??
- A.** No.
- Q.** I am going to hire a 100% combat disabled veteran. How do I or what forms do I need to complete to have my business qualify/be certified for all hiring preference points?
- A.** An RFP is not a hiring process, therefore no hiring points apply. Offerors may qualify for the Alaska Veterans Preference per AS 36.30.175.

**5 Percent Alaska Veteran Preference  
AS 36.30.175**

An Alaska Veteran Preference of five percent will be applied prior to evaluation. The preference will be given to an offeror who qualifies under AS 36.30.170 (b) as an Alaska bidder and is a:

- (a) sole proprietorship owned by an Alaska veteran;
- (b) partnership under AS 32.06 or AS 32.11 if a majority of the partners are Alaska veterans;
- (c) limited liability company organized under AS 10.50 if a majority of the members are Alaska veterans; or
- (d) corporation that is wholly owned by individuals and a majority of the individuals are Alaska veterans.
