This is for evaluation purposes only. This is a correction to the Sample Project – Kayak Island, the weight should be approximately 40,000 not 4,000.

Kayak Island-Scope of Work: Debris Monitoring, Removal, and Disposal

The offeror must submit a cost proposal with a total cost for a sample project consisting of the removal and disposal of 400 cubic yards (weight approximately 40,000 pounds) of high-windage, inert, non-hazardous marine debris (e.g., plastic, buoys, and foam) from a ten-mile stretch of beach accessible by boat on the NE end of Kayak Island. The project is to be completed, assuming calm seas, between August 1, 2013 and August 31, 2013.

Cost Factors to consider (not all inclusive): personnel costs, wages, taxes, per diem, insurance, fuel costs, vessel lease and/or operational costs, equipment, shipping, recycling, disposal, and administrative costs and/or overhead.

This is a NEW request for cost proposal. This is a sample project for evaluation purposes only and is required for your proposal to be deemed responsive, regardless of which region(s) the offeror intends to work in.
