# Per Section 6.27 Alaska Business License and Other Required Licenses

Prior to award of a contract, selected teams must hold a valid Alaska Business License. <u>However, in order to receive the Alaska Bidder Preference, an offeror shall have a valid Alaska business license prior to the deadline for receipt of proposals/Statement of Qualifications.</u>

In order to qualify for the Alaska Offeror's Preference, the offeror must be qualified as an Alaskan bidder.

The requirements for the Alaskan Bidder's Preference:

### **REQUIREMENTS:**

#### The bidder must:

- Hold a current Alaska business license and submit a bid under the name on their business license.
- o Have maintained a place of business within the state staffed by the bidder or an employee of the bidder for at least six months immediately preceding the date of the bid.

#### AND, if the bidder is a:

- o CORPORATION, is incorporated in Alaska or are otherwise qualified to do business under the laws of the state.
- o SOLE PROPRIETORSHIP, the proprietor must be a resident of the state.
- o LIMITED LIABILITY COMPANY organized under AS 10.50, all members must be residents of the state.
- o PARTNERSHIP under AS 32.05, 32.06, or 32.11, all partners must be residents of the state.
- o JOINT VENTURE, the joint venture must be composed entirely of ventures that qualify as Alaska bidders.

BUSINESS LICENSE FEES: Business license fees are non-refundable once the business license has been issued. Business License fees are \$50 per year and may be purchased for 1 or 2 years. All business licenses expire on December 31st regardless of the date of purchase.

## Per Section 3.03 Certification - Foreign Contracting (Required for Phase 2)

By signature on this solicitation, the offeror certifies that all services provided under this contract by the contractor and all subcontractors shall be performed in the United States. If the offeror cannot certify that all work is being performed in the United States, the offeror must contact the Procurement Officer to request a waiver at least 10 days prior to (**Phase 2**) proposal deadline. The offeror must provide with their submission a detailed description of the portion of work being performed outside the United States, where, by whom and the reason the waiver is necessary.

It is required to provide enough information to determine who is doing the work, what are they doing and the approximate portion of work being performed outside the United States. It is understood that not all the details may be available at this time. The waiver is required for Phase 2

- (5) A sworn notarized affidavit that the bidder/proposer has applied and paid for the Alaska Business License.
- (6) Other form of evidence acceptable to the Department of Law.
