The goal is to cap the moose population before they reach their carrying capacity, rather than see them crash because of over-population. The use of this management tool needs to be closely monitored. People remember the 1960's open season mentality and the crash that occurred afterwards. This is managed by a limited draw. 10 does not accomplish the desired objective and this committee believes anything less than a harvest of 50, if 10 only took 2 this past fall. There was some discussion of doing this as a registration antlerless hunt. | | | | | |

Federal Subsistence Proposals

WP 14-01 Parks Service has a trapping – checking, marking snares, identifying traps

Oppose -0-11 Six day trap checks in our area is not realistic. Weather has as much concern of trap checks as anything. Valdez is starting something like this because of a problem with a local dog running loose. Once this type of thing starts it never stops and only gets more cumbersome. People are getting out on the trails more – trapline signage that states "Active"

Trapline" goes a long way for prevention of problems. The last thing a trapper wants to catch is someone's dogs.

Another proposal about winter moose hunt is still pretty much in the discussion stage. The folks in McCarthy are asking for some kind of winter moose hunt with limited permits in December. They have moose pretty far out and a difficult Unit to hunt, but the moose come out of the river in the winter time. They would like to harvest a few of those animals. The Resource Commission supported it, but there have never been any surveys by the Park Service or the state. They are asking for a registration hunt that would be eligible for the resident zone communities. Because of the time of year and where it's at, will self-limit those that are interested in participating.

Ruth McHenry 5 year land permit Southcentral Region Butte Lake – Susitna winter road DOT comment (would be open to the public). Think it will be restricted to no hunting. Application for use of state land – crews will be grooming cross country trail. Early November when things aren't frozen too hard, perhaps narrowing the time frame.

Barbara Cellarius provided a map of the federal hunt area for moose caribou.
