These revisions add editor's notes to alert the reader of the delayed printing of certain regulations changes.

On January 9, 2013, the Alaska Housing Finance Corporation adopted 15 AAC 151.850 -15 AAC 151.870 (mortgage facilitator program) and made a conforming amendment to 15 AAC 151.950(e). Those regulations changes are not subject to AS 44.62 (Administrative Procedure Act), and took effect immediately upon adoption as provided under AS 18.56.088. Though the regulations changes were adopted and took effect on January 9, 2013, the first register of the Alaska Administrative Code in which they will appear in print is Register 213 (April 2015). Accordingly, we are forwarding to the publisher new editor's notes and revisions to existing editor's notes to alert the reader to the publication delay, as follows:

1. After 15 AAC 151.850, please insert an editor's note to read as follows:

4. After 15 AAC 151.865, please insert an editor's note to read as follows:

Editor's note: Even though 15 AAC 151.865 was adopted and effective 1/9/2013, it was not published until Register 213, April 2015.

5. After 15 AAC 151.870, please insert an editor's note to read as follows:

Editor's note: Even though 15 AAC 151.870 was adopted and effective 1/9/2013, it was not published until Register 213, April 2015.

6. At the end of the editor's note that follows 15 AAC 151.950, please add a new third paragraph (in addition to the existing paragraph, and the new paragraph requested in my revisor's memorandum regarding 15 AAC 151.950(d)), to read as follows:

Even though an amendment of the introductory language of 15 AAC 151.950(e) was adopted and took effect 1/9/2013, the amendment was not published until Register 213, April 2015.

As of Register 213 (April 2015), the regulations attorney made a conforming technical revision under AS 44.62.125(b)(6), to the definition of "commercial uses" in 15 AAC 151.950(d), so that the original cross-reference to AS 18.56.340 now refers to AS 18.56.230, the number assigned to the section upon codification.
