3. The following is clarification to Section 07532 – Ethylene-Propylene-Diene-Monomer (EPDM) Roofing 2.2. D. “Conform to ICC and IBC as adopted by the City of Seward, Alaska for roof assembly fire hazards and wind uplift resistance requirements. Design for 120 mph wind, 3-second gust, exposure B.”
